- ❖ The competition will be conducted in accordance with the rules of the ECHDA and the Scottish Official Board of Highland Dancing.
- ❖ All competitors must present their current 2019 SOBHD registration card to receive awards and must remain in costume for all award presentations.
- ❖ Categories as defined by the S.O.B.H.D. Age categories for Pre-Premier Competition will be based on number of registrants in each classification.
- ❖ Age as of May 12th, 2019
- ❖ First to enter, last to dance.
- ❖ Dancers must report promptly to dance area when called or risk disqualification in that event.
- ❖ Dancers must use the changing room, there is no changing allowed in the foyer or in the dancing area.
- ❖ Medal placings to top 6 places in each Primary, Beginner, Novice and Intermediate groups.
- ❖ Winner and Runner-up trophies will be awarded to all groups except Primary. Beginner, Novice and Intermediate sections will be given a overall perpetual trophy to the dancer in each category with the highest points. Perpetual trophy awarded to the most promising Pre-Premier dancer of the day.
- ❖ Dancers must dance in numerical order.
- ❖ Numbers will be handed out the day of the competition.
- ❖ Any complaint made by an individual against the ECHDA or adjudication of a ECHDA event, must be made in writing giving the complainant's full name and address and lodged with the ECHDA, if possible on the day of the event but certainly not later than 48 hours after the event. A deposit of \$25.00 must accompany any complaint. The deposit shall be returned should the complaint be upheld. If within seven days of lodging such complaint and the complainant has received no satisfaction from the ECHDA, the complainant then may refer the matter to ScotDance Canada.
